1.- Object of advertising promotion

2.- Dates of advertising promotion

Valid from 16 September to 29 October. They are excluded from this advertising promotion on 12, 13, 14 and 15 October 2023.

3.- Benefits of advertising promotion

The members of the photography type "selfie" will win a second trip in Tobotronic **in the purchase of tickets Tobotronic + Menu, entry Adventure and entry Adventure +.**

4.- How to benefit from advertising promotion

Those interested in benefiting from the advertising promotion will have to present the "selfie" image at the ticket office in order to receive an extra trip in Tobotronic with the purchase of the tickets mentioned in section 3.

The "selfie" type image will be validated by the seller of each box office, which will decide whether the screen of Casa Bergé - as set out in paragraph 1 of this document- as well as the people who appear into the picture, which must be recognised by the seller.

The "selfie" type picture will only be consulted by the seller, not being registered or stored at any time by CAMPRABASSA.
